I am the research coordinator hired by the Saskatchewan Games Council Inc. to conduct research relating to the Saskatchewan Games program ahead of its 50<sup>th</sup> anniversary. I would like to conduct an interview with you to learn about your own experiences.

This study involves interviews with about 50 alumnae who participated in either the Winter or Summer Saskatchewan Games between 1972-2018. I would like to create a “picture” of the importance of the Games across the province in relation to participants. The interview consists of four types of questions (introductory, Games—General, Games—Specific, and Participant—Specific, and will last between 30 and 45 minutes depending upon how much you have to say. There is no “right” answer to any of the questions and any question can be skipped at any time.

I do not anticipate any risks to you or others related to the interview.

You are under no obligation to participate, and you may end the interview at any time. If you choose to end the interview early, you may wish to tell me that I cannot use the information you have provided. Also, if you change your mind at any time after the interview is completed, you can also tell me that I cannot use the information you have provided.

The information you provide will help to create programming and interpretation for the upcoming 50<sup>th</sup> Anniversary Saskatchewan Winter Games held in 2022 in Regina. Your answers will be stored on my personal desktop computer, an external hard-drive, and a shared google folder, which is accessible to my supervisor and myself.
